### **Terms and Conditions**

### 1. General Information

These Terms apply to all users of our website, including those purchasing products or engaging with our services. They comply with the UK Consumer Contracts (Information, Cancellation, and Additional Charges) Regulations 2013 and other relevant laws.

# 2. Placing an Order

#### 2.1. Eligibility

By placing an order, you confirm that:

- You are at least 18 years old or have parental/guardian consent.
- The details you provide are accurate and up to date.

#### 2.2. Order Confirmation

Once you place an order, you will receive an email confirmation. This serves as acknowledgment of your order but does not constitute acceptance. We reserve the right to refuse or cancel orders due to:

- Stock unavailability.
- Pricing or listing errors.
- Suspected fraudulent activity.

### 2.3. Payment

We accept payments via major credit/debit cards, PayPal, Klarna, Amazon Pay, Apple Pay, and Google Pay. Payments are processed securely, and your payment information is not stored by us.

### 3. Delivery Policy

### 3.1. Delivery Timeframes

Delivery options and timeframes are outlined on our Delivery Information page. While we strive to meet these timeframes, delays may occur due to factors beyond our control (e.g., courier delays or peak periods). Orders are dispatched within 1–2 business days unless stated otherwise.

#### 3.2. Free Delivery

Orders over £75 qualify for free Economy Delivery. Full details of delivery costs and upgrades are provided at checkout.

### 3.3. Tracking

Real-time delivery updates depend on the courier's capabilities. School Wear United is not responsible for delays once the package has been handed to the courier.

#### 4. Cancellations and Returns

### 4.1. Right to Cancel

Under the Consumer Contracts Regulations, you have the right to cancel your order within 14 days of receiving your items. To exercise this right, you must notify us via email or WhatsApp.

#### 4.2. Exemptions

The following items are exempt from cancellation:

- Personalised or customised items.
- Products that are unsealed and unsuitable for return due to hygiene reasons (e.g., socks).

#### 4.3. Return Process

To return an item, contact us to arrange a return authorisation. Items must be:

• Unworn and in their original packaging.

- Returned within 14 days of notifying us of your intent to return.
- Return postage costs are the customer's responsibility unless the item is faulty, damaged, or incorrectly supplied. Refunds will be processed within 14 days of receiving the returned item.
